**LOCATION OF UNIT:** The Model 7610 Eye/Face wash should be installed in close proximity to potential accident areas. It should be clearly identified free from obstructions and easy to access.

**SUPPLY LINE**: The minimum recommended line size is 1/2" IPS with 30-90 psi (2-6 ATM) pressure. Where sediment or mineral content is a problem, an inlet filter is recommended.

PLUMBING CONNECTIONS: Inlet supply is 1/2" O.D. slip joint.

1.	No flow.	1.		Check the main shut-off valve.						
2.	Insufficient water flow.	2.		Verify minimum 30 psi (2 ATM) flowing supply line pressure. Probable clogging of flow control due to inadequate line flushing. Unscrew eye/face wash head and remove the four screws to disassemble head. Clean flow control and reassemble head.						
3.	Eyewash stream does not meet desired eye level.	3.	a. b.	Possible blocked flow control, see above solution. Possible non-leveled eyewash assembly.						

#### INSTALLATION INSTRUCTIONS

Refer to installation drawing to clarify installation procedure.

**Note**: Model 7610 Eye/Face Wash can be mounted on either right or left side of the sink. For left hand use, reconfigure as shown on installation drawing.

- **STEP 1:** Remove the 1.25 O.D. flange nut and washer from valve body.
- **STEP 2:** After making sure that top and bottom surface of the counter top or deck, around the drilled hole is clean and free of grease, slide valve through drilled hole from the top.
- **STEP 3:** Reinstall the 1.25" O.D. flange nut and washer. Connect slip joint connection to complete installation.






PULLDOWN EYE/FACE WASH LABEL P/N 0003163821



SP175 EYEWASH SIGN











# PROCEDURE FOR LEFT-HAND CONVERSION




# STEP 1:

(SHOWN IN CLOSED POSITION)
REMOVE BEND FROM BODY. HAWS RECOMMENDS
THE USE OF A SOFT TOOTH VICE TO PREVENT
MARKINGS ON CHROME PLATED PARTS
THROUGHOUT ENTIRE PROCEDURE.




# STEP 3:

REMOVE RETAINER SEAT, SLEEVE AND SEAT FROM BODY. REMOVE SCREW.



# STEP 2:


REMOVE EYEWASH ASSEMBLY FROM BEND.




## STEP 4:

LOOSEN AND BACK OFF SOCKET SET SCREW WITH 3/32" HEX WRENCH. REMOVE CAP AND SPOOL. NOTE EXISTING ORIENTATION WATER PORT IN R.H. CLOSED POSITION.






ROTATE SPOOL 180°, INSERT INTO BODY. INSERT ENGAGE SLOT ON SPOOL. ATTACH CAP, SECURE SCREW AT LEFT SIDE OF BODY, SCREW MUST WITH SOCKET SET SCREW. (THIS IS NOW IN L.H. CLOSED POSITION).




BEND. USE LOCTITE #565 THREAD SEALANT ON MALE THREADS OF BEND (EACH END). ATTACH BEND TO BODY, THEN HEAD ASSEMBLY TO BEND, SEE STEP 8 FOR ORIENTATION OF

SEAT TIGHTLY. INSERT SLEEVE, SEAT AND SCREW RETAINER



FROM CENTER OF BODY TO CENTER OF EYEWASH NOTE PROPER ORIENTATION OF BEND; 2-1/8" TEE. THE 75° IS FOR REFERENCE ONLY.
